

# YOUTH TEAM STORE PARTNERSHIP AGREEMENT

This Agreement is entered into between Precision Signs Inc. (MCC) and [Club Name] ("Club").

The purpose of this agreement is to establish a partnership to create and operate an online merchandise store for the Club.

## 1. TEAM STORE PROGRAM

MCC will design and operate an online merchandise store for the Club where players, families, and fans can purchase Club-branded apparel and merchandise.

The Company will be responsible for:

- Designing merchandise graphics
- Producing merchandise after orders are placed
- Processing payments
- Shipping products directly to customers
- Providing basic customer service for orders

The Club will be responsible for:

- Promoting the team store to players and families
- Providing logos or branding assets (if applicable)
- Ensuring they have permission to use any logos submitted

## 2. PROFIT SHARING

The Club will receive 15% of net profits from merchandise sales generated through their team store.

MCC will provide the Club with quarterly sales reports showing total merchandise sales and the amount earned by the Club through the profit share program.

Payments to the Club will be issued quarterly.

Payments will be sent via check.

From time to time, MCC may collaborate with the Club on special or limited-edition merchandise drops. For these limited releases, the Club may earn up to 20% of net profits depending on the promotion and product offering.

## 3. MERCHANDISE PRODUCTION & FULFILLMENT

All merchandise sold through the team store is produced after purchase (made-to-order).

Typical production and shipping time is 7–14 business days, though times may vary during high demand periods.

MCC is responsible for production, fulfillment, and shipping logistics.

## 4. RETURNS & ORDER ISSUES

Because items are made to order, returns for size or preference are generally not accepted.

If an item arrives damaged, defective, or incorrect, MCC will replace the item at no cost to the customer.

## 5. LOGO & ARTWORK PERMISSION

The Club confirms that it owns or has permission to use any logos, team names, or graphics submitted to MCC for merchandise production.

The Club grants MCC permission to use these materials for the purpose of producing and selling Club merchandise.

## 6. DESIGN RIGHTS

Custom merchandise designs created by MCC may be used in the Club's team store and promotional materials related to the store.

## 7. TERM OF AGREEMENT

This agreement begins on the date signed and remains in effect until terminated by either party.

Either party may terminate this agreement with 30 days written notice.

## 8. LIMITATION OF LIABILITY

MCC is not responsible for delays caused by shipping carriers, supply chain issues, or events outside its control.

## 9. AGREEMENT ACCEPTANCE

By signing below, both parties agree to the terms outlined in this agreement.
